10. Consent Agenda (Chair)

- 10.1 Request the RCS Board approve a new RCS Media Customer Agreement for Station Venture Operations – KNSD-TV.

Staff background/ recommendation: Station Venture Operations – KNSD-TV is a new media customer that provides video to other media outlets in San Diego County. Media customers have a limited fleetmap and no transmit capability, and pay the NOC rate of \$28.50 per radio per month. KNSD-TV proposes to start with four (4) radios and eventually expand to 10 radios. Staff recommends approval.

- 10.2 Request the RCS Board approve a new RCS Customer Agreement for Viewpoint Ambulance.

Staff background/ recommendation: RCS Customer Service Agreements will expire on March 31, 2021. The Customer Service Agreement requires an amendment to extend the term to June 30, 2026. The Agreement includes a provision to amend the contract and extend the term upon approval of the RCS Board. Staff recommends approval.

- 10.3 Request the RCS Board approve San Diego Gas and Electric (SDG&E) to increase their radio limit from 400 radios to 1,000 radios.

Staff background/ recommendation: SDG&E is an existing customer with 400 radios under the agreement. SDG&E has reached its maximum limit and requests to add up to 600 radios to meet their current and future needs. Staff recommends approval.

- 10.4 Request the RCS Board approve U.S. Department of Interior Bureau of Land Management (BLM) to increase their radio limit from 50 radios to 90 radios.

Staff background/ recommendation: BLM is an existing customer with 50 radios under the agreement. BLM has reached its maximum limit and requests to add up to 40 radios to meet their current and future needs. Staff recommends approval.

- 10.5 Request the RCS Board approve a Delinquent Account Payment Plan Agreement with Coast Medical Transport.

Staff background/ recommendation: Coast Medical Transport is an existing RCS Customer with a delinquent account. Radios were deactivated in May 2020 due to non-payment of account since June 2019. There was a recent change of ownership and the new owner reached out to RCS to settle the company's outstanding account and requested to reactivate some radios for operational needs. A payment plan is presented to Coast Medical, whereby the balance of \$6,195.42 will be paid in 12 months starting November 1, 2020. Coast Medical acknowledges and agrees that if the payments were not made as agreed upon, including payments on current bills, the account will be immediately terminated, and radios will be deactivated. Staff recommends approval

- 10.6 Request the RCS Board approve a five-year extension to RCS Customer Service Agreement per list attached. (Attachment A).

Staff background/ recommendation: RCS Customer Service Agreements will expire on March 31, 2021. The Customer Service Agreement requires an amendment to extend the term to June 30, 2026. The Agreement includes a provision to amend the contract and extend the term upon approval of the RCS Board. Staff recommends approval.
